If there should be any accident that is caused by me and leading to damage University property or other swimmers, I will take complete legal responsibility.

國立東華大學履行個人資料保護法告知說明：

一、蒐集目的：辦理游泳證個人資料建檔、泳池進出管理、緊急聯絡之用。

二、蒐集之個人資料類別：姓名、單位/系所級、身分、身高、學號（東華學生）、

身分證字號（東華教職員生/校外人士）、通訊處、電話、緊急聯絡人姓名、電話。

三、個人資料利用之期間、地區、對象及方式：

期間：因執行業務所必須及依法令規定所要求之期間。

地區：辦理游泳證所在地區。

對象：申辦游泳證本校教職員生及校外人士。

方式：合於法令規定之利用方式。

四、依據個資法第三條規定，台端就體育中心辦理游泳證保有 台端游泳證申請書上之個人資料得行使之權利：

- (一)、查詢或請求閱覽。
- (二)、請求製給複製本。
- (三)、請求補充或更正。
- (四)、請求停止蒐集、處理或利用。
- (五)、請求刪除。

五、台端不提供個人資料予體育中心所致權益之影響：

台端若未能提供泳證辦理相關個人資料時，將無法進行必要之審核及處理作業，致已繳費期間無法進出游泳池使用相關設備。

National Dong Hwa University notifies swimpass applicants items as follows pursuant to Personal Information Protection Act:

1. Purpose of collection: keep on file swimpass applicant's information for swimpass data, entry/exit of swimming pool management, emergency contact.
2. Classification of the personal information: name, office/dept, identity, height, student card number--Dong Hwa students, ID card number--Dong Hwa faculty, students and non Dong Hwa personnel, address, telephone number, emergency contact's name and telephone number.

3. Time period, area, target and way of the use of personal information:
- time period: under the necessity of business and as stipulated in law.
- area: the area where swimming pass application is relative to.
- target: swimpass applicants such as Dong Hwa's faculty, staff, students, non Dong Hwa personnel.
- way of the use of personal information: where in accordance with law.
4. The following rights should be exercised by the swimpass applicant with regard to his personal information as prescribed in article 3 of Personal Information Protection Act:
- (1) . any inquiry and request for a review of the personal information;
 - (2) . any request to make duplications of the personal information;
 - (3) . any request to supplement or correct the personal information;
 - (4) . any request to discontinue collection, processing or use of personal information; and
 - (5) . any request to delete the personal information.
5. The influence on rights and interests while the swimpass applicant chooses not to provide his personal information:
- If applicant fails to provide relative personal information to PE Center, then the necessary check and production of his swimpass can not be done, that will cause him be unable to enter or exit swimming pool of Dong Hwa university for the period of time that he applies and pays for.
